## Fees & Enrolment

- 1) A student is accepted for enrolment on and subject to the condition that the student will attend on the date (the commencement date) and at the time specified in the confirmation letter which will be sent to the student upon receipt of the completed application form together with the correct registration fee.
- 2) Registration Fees are not-refundable but shall be credited against the course fee.
- 3) The balance of the full workshop fee should be paid no less than 30 days prior to the commencement date. There's a 10% discount available if paid in full 10 months in advance.
- 4) Upon notification of the commencement date no variation in the course date will be permitted.
- 5) All fees quoted attract and are inclusive of VAT (UK Government Tax) at the current rate. All fees must be received by the workshop without deduction, therefore any overseas/UK bank charges will automatically be added to the final balance.
- 6) In the event of a student failing to attend the confirmed workshop or complete the course for any reason, no refunds will be made and no entitlement to a later workshop will be gained.
- 7) Fees are not refundable if the workshop is interrupted or cancelled through an act of God or terrorist act.
- 8) Students will not be accepted on the commencement date unless full payment of fees is made. A receipt for registration fee will be sent with letter of confirmation and receipt for balance upon receipt for such amount.
- 9) A deposit of 20% of workshop fee is required to book a place.

## Hours

Workshops commence at 10am and finish at 5pm- Monday to Friday. Workshop hours can be varied at the discretion of the Administrator without prior notice.

Premier Beauty Workshop will be closed on all UK public Holidays.
